Policy Statement

General Guidelines

These guidelines apply to any and all products in the Greens Best Nutrition™ line. This MAP policy applies to the advertised price of a product before shipping, handling, or additional charges are imposed.

Distributor/Reseller Guidelines

To better protect our product integrity, any distributor, and reseller of our products are responsible for the MAP policy compliance of their customers and any business entities to whom they are supplying. This includes disclosing all valid website information, domain addresses, and contact information of which the Greens Best Nutrition™ products are being sold.

Advertising Guidelines

All advertised pricing by any medium, including, but not limited to, print, internet or similar electronic media, radio, television, etc., cannot be more than 15% below our MAP pricing.

MAP pricing only applies to the advertised price. Temporary promotions, sales and discounts that effectively lower the retail price are permitted as long as they are not directly applied to the advertised price.
